• Questionable Transactions:

Bank Account:

- It has been decided that YSSA will close the Vibrant Account and move the account to US Bank.
 - All monies should be in the process of being deposited into the US Bank account
 - Eddy Boggs has money that he needs to deposit currently he is holding on to the money
- Bill Peterson has received confirmation that all paperwork has been turned in and money is deposited into the US Bank - YSSA Account

Leadership?

- Future president of YSSA?
 - Tim Baldwin? Prefers not at this time as he does not have an athlete active in YSSA. Time commitment to multiple disciplines is demanding
 - o Bill Peterson will step aside and move to an advisory role

 - Once Bill Peterson steps down . . .

- All YSSA materials will be sent to a PO Box
- Probably needs to be located in Illinois close to the Indoor Range
- This was approved by all present at the June 6, 2020 YSSA Board Meeting

Archery:

- Athletes are to remain in vehicles until ready to take the line
 - Then 10' apart while practicing
 - Use hand sanitizer before & after shooting
 - Start on July 14th Eddy Boggs & Joe Janz will send out a notice to the archery athletes
- New targets need stands this was approved

Shotgun:

- Bi-State is open on Tuesdays & Thursdays but the athletes will need to work among the members due to low numbers from YSSA attendance on Thursdays
- YSSA NO LONGER HAS AN ASSIGNED NIGHT FOR PRACTICE BUT NEEDS TO FOLLOW THE REQUIREMENTS TO SHOOT AT BI-STATE
 - YSSA athletes will need a coach present to shoot Who is registered as a coach through YSSA?
 - YSSA athletes will need to sign in on a ledger for Bi-State reimbursements from YSSA
 - Bill Peterson and Don Collins will arrange and work together on this'
 - Athletes will need to verify the balance prior to placing money on their Bi-State cards
 - If they do not know their balance then money is to be paid at time of target purchase
 - May attempt to get balances to Taylor for his reference
 - Taylor will need to document withdrawals and information conveyed to YSSA for reimbursement
- Taylor (worker for Bi-State) will run the counter, collect money for targets and place on Bi-State card
- John Ager not available on Thursdays due to SCTP, NRA & NSSA Competitions

Shotgun - IA ISTA Competition in Cedar Falls, IA (July 21 - 26) CANCELED

- John Ager to create a Junior Squad to represent YSSA
 - Midway USA endowment money is available upon placement in events
 - Michael Lemburg
 - Luke Ager

Shotgun - AIM Grand Competition in Linn Creek Missouri (August 2 - 4)

- John Ager to take 2 squads to represent YSSA
 - Pulled athletes from Ankeny to compete with YSSA
 - Ankeny athletes will fill out YSSA paperwork and Bill Peterson will get to squadding

- If Ankeny athletes pay \$50.00 to YSSA . . . (Per conversation between Bill Peterson & John Ager after June 1, 2020)
 - Will receive a flat of AA Winchester Ammo
 - Will have their 200 single targets paid for
- If Ankeny athletes do paperwork only . . .
 - Will have their 200 single targets paid for
- Kent Keeshan to take a squad to represent North Scott Trap Team
 - No ammo will be provided
 - Single targets will not be paid for

Pistol & Air Rifle:

- Looking for a coach for these disciplines
- Currently only have 2 active athletes Would a parent of these athletes be willing to be coach certified?
 - Victor Cincola's son for air rifle
 - Adam Axtell's son for pistol
 - Neither parent has been contacted about becoming a coach for their athlete
